Terms and Conditions of participation

1. Deadline for submitting your travel details to the International Buyers Department or to the Regional Advisor if you do not need to apply for visa:

26th September 2019 – If you receive written confirmation by 31 August 2019

10th November 2019 - If you receive written confirmation from 1st September to 31st October 2019

within 15 days from the date of confirmation - If you receive written confirmation from 1st November 2019 onwards

Should you be unable to abide by these deadlines due to force majeure, you are kindly requested to inform your SIGEP/ABTECH 2020 referent immediately.

Failure to abide by these deadlines will entail a 50% reduction of the lump sum reimbursement for the flight. Moreover, Italian Exhibition Group Spa will also reserve the right to cancel your participation in SIGEP/ABTECH 2020 should you fail to respect these deadlines.

2. Deadline for submitting travel details to the International Buyers Department or to the Regional Advisor if you do need to apply for visa:

If you receive a written confirmation for participation in SIGEP/ABTECH 2020 and you need to apply for a visa you will have to submit a copy of your passport and your personal details to receive an invitation letter.

Upon receiving your invitation letter, you will do your best to apply for a visa on the earliest date permitted by the law in order to speed up the visa issuing process. Once you have received your visa, you will have to inform the International Buyer Dpt. directly or the Regional Advisor immediately and at the same time provide your travel details/flight details (flight no., schedule and airport of arrival and departure).

30th October 2019 – If you receive written confirmation by 31st August 2019;

23th November 2019 - If you receive written confirmation from 1st September to 31st October 2019;

10th December 2019 - If you receive written confirmation from 1st November 2019 onwards;

Should you be unable to abide by these deadlines due to force majeure, you are kindly requested to inform your contact person for SIGEP/ABTECH 2020 immediately.

Failure to abide by these deadlines will entail a 50% reduction of the lump sum reimbursement for the flight. Moreover, Italian Exhibition Group Spa will also reserve the right to cancel your participation in SIGEP/ABTECH 2020 should you fail to respect these deadlines.

Flight lump sum reimbursement: the reimbursement of the lump sum as partial refund of the flight ticket will be made in cash during SIGEP/ABTECH 2020 and only upon receipt of an invoice (with TIN no. invoice no. Company name and address), a copy of the passport and a copy of the flight ticket **by 10th December 2019**.

A maximum of 1 accompanying person will be granted access to the buyers' lounge. Accompanying persons under 18 years of age are not allowed to enter the buyers' lounge.

3. Business meetings

In the present document, I commit myself:

- to arrange **15 business meetings** with SIGEP/ABTECH 2020 exhibitors through the web platform from 27th November 2019 to 14th January 2020;
- to send at least **10 meeting requests** to SIGEP/ABTECH 2020 exhibitors through the web platform by 10th December
- to **respect the business meetings' schedule** agreed with exhibiting companies during show days (if I fail to arrange 15 meetings through the web platform, I undertake to visit other exhibiting companies in order to achieve the number of 15 meetings);
- to deliver the copy of my agenda to my Country contact person **completed with the all the signatures** of the meetings held (I will ask for the exhibitors' signature at the end of each meeting);
- to come back to SIGEP/ABTECH 2020 the days after the Business Meetings to meet other exhibiting companies;
- to complete the online survey after completing all business meetings.

Italian Exhibition Group will offer the following services **only if I participate in the pre-scheduled B2B meetings at the agreed times and I actively arrange these meetings through the web platform:**

- 4 nights' accommodation in a 4* hotel – breakfast included (arrival on 17th January, departure on 21st January)
- Lump sum reimbursement of € 800 for flight expenses (if the flight costs less than € 800, the lump sum will be refunded of the effective flight cost)
- Interpreting service for one day only if I do not speak English fluently;
- Buffet lunch at the fair;
- Transfer (Shuttle Bus) from the airport (Bologna A. Marconi) to the Hotel and back
- Daily transfers (shuttle Bus) from the Hotel to the Expo Centre and back;
